6 MEMBERSHIP TYPES

\$65 – Skater \$35 – For Each Additional Skater

This membership is for skaters and additional skaters. Skating members over the age of 18 have voting rights and can serve on the Board of Directors if elected. Skating members under the age of 18 must have a parent/guardian join as a Skater, Non-Skater or Professional Membership. Skating members may participate in all club activities and are eligible for Training/Competitive Reimbursements.

\$35 each – Non-Skater/Parent: This membership is for supportive family members who are not skaters or professionals. Non-Skater members over the age of 18 have voting rights and can serve on the Board of Directors if elected. Non-Skater members may participate in all club activities and are eligible for Judging Reimbursements.

\$65 – Professional: This membership is for those who are considered to be ineligible persons under the Eligibility rules of the USFSA. Professional members over the age of 18 have voting rights and can serve on the Board of Directors if elected. Professional members may participate in all club activities and are eligible for Coaching Reimbursements.

\$40 – Adult or Youth Basic Skills Membership: \$35 – For Each Additional Basic Skills Skater:

This membership is for those who are Basic Skills participants who have passed no USFSA tests other than pre-preliminary MITF or adult pre-bronze MITF. If within the membership year a Basic Skill Member wishes to test an additional fee will be required. The fee will be the difference between the Basic Skills Membership Fee and the First Skater Fee (\$25). Basic Skills members over the age of 18 have voting rights and can serve on the Board of Directors if elected. Basic Skills members under the age of 18 must have a parent/guardian join as a Skater, Non-Skater or Professional membership. Basic Skills members may participate in all club activities and are eligible for Training/Competitive Reimbursements.

\$90 – Collegiate Membership (4 years): This membership is for skaters who will be/are attending college and want to remain an active member of this club. **Proof of full time enrollment is a 4 year college must be submitted with this application.** Collegiate members over the age of 18 have voting rights and can serve on the Board of Directors if elected. Collegiate members under the age of 18 must have a parent/guardian join as a Skater, Non-Skater or Professional Membership until age 18. Collegiate members may participate in all club activities and are eligible for Training/Competitive Reimbursements.

\$65 – Associate: This membership is for those whose primary affiliation is with another USFSA member club. Associate Members may participate in all club activities. Associate members have no voting rights, are not eligible for Reimbursements and not eligible to serve on the Board of Directors.

**** PLUS \$10 – Paper Processing Fee:** Added to all new registrations and renewals submitted in paper form.
